The fund is approved in Republic of North Macedonia and is regulated by the Security and Exchange Commission. The Fund is approved with Decision by SEC no. 07-591/4 dated 15.04.2009. The expressed key information for the investors is accurate on 31.3.2022.

Objectives and Investment Policy

The Fund by its structure and characteristics is a combination of investments in stocks and bonds. It is intended for investors who want to use the opportunity to achieve higher returns through the part invested in stocks, while at the same time to ensure stability and security of the invested assets in the fund through investments in bonds. In terms of stocks, the Company shall apply an active strategy without pre-defined criteria such as "value", "growth" or "high dividends".

The Company shall invest the Fund assets in the following instruments:

- **Asset Class A** (min. 10% - max. 75%) investments in stocks issued by entities from the Republic of Macedonia, Croatia, Serbia, Montenegro, Albania, Bosnia and Herzegovina, Ukraine, Russia, Brazil, India, China, EU and OECD;
- **Asset Class B** (min. 0% - max. 80%) investments in short term and long-term fixed income securities issued by entities from the Republic of Macedonia, Croatia, Serbia, Montenegro, Albania, Bosnia and Herzegovina, EU and OECD;
The investments in fixed income securities issued by RNM, member countries of EU and OECD can be over 35% of the Fund's assets;
- **Asset Class C** (min. 0% - max. 100%) investments in deposits with banks in RNM with maturity date less than a year and money market instruments which are traded on organized markets, issued by entities from the RNM, countries members of the EU and OECD; and
- **Asset Class D** (min. 0% - max. 10%) investments in open-end investment funds which are mainly investing in stocks and fixed income securities issued by entities from Southeast Europe, Ukraine, European Union, OECD, Brazil, China, India, USA, and Russia, provided that the management fees are less than 2,5%.

The income from instruments in which Fund assets are invested, such as capital gains, dividends, foreign exchange gains, and interest income, will not be distributed to the owners of shares; but they will be automatically reinvested in order to increase the price of the Fund shares. The Fund investment strategy and the financial instruments selection suggest investment in medium term with pre-defined term of investment, that is, this Fund is intended for investors who want to invest their assets for at least 1 year.

Risk and Success Profile

The synthetic risk indicator indicates a moderate level of risk that is lower than usual, and this is mainly due to bank deposits and fixed income instruments, as well as low volatility of investments in equity securities by domestic issuers.

The following risks may have significant impact to the proceeds:

- **Credit risk** – risk that the issuer of security, will not be able to meet its obligations, in time and/or in full;
- **Liquidity risk** – risk that the Fund will have difficulties for finding adequate amount of cash to meet its obligations arising from withdrawal of shares in the Fund as a result of inability to sell financial instruments fast at the price close to their fair value;
- **Counterparty risk** – risk that the entity with which the Company, on behalf of the Fund, concludes transactions in the financial markets, will not be able to meet its obligations, in time and/or in full.

The funds for buyout of shares are paid to the investor's transaction account upon submitted Request until 14:00 in the day for payment the next working day. The prices for sale of new shares or buyout of the existing ones are calculated every working day until 16:00 and are published on the Company's website. The historical data used for the calculation of the synthetic indicator should not be considered as a reliable indicator of the future risk profile of the Fund. The category of risk and success profile is not a guarantee that they will remain unchanged, i.e. the categorization of the Fund may change over time. The lowest category does not mean that the investing is risk-free.

Entry and exit fees are always expressed in the highest amount, i.e. in certain situations the investor may pay a lower amount. The entry fee depends on the type of payment (one-time/plan or scheduled payments), as well as the amount of funds stated in the Request for purchase

of shares. The exit fee is anticipated and depends on the amount of funds withdrawn. The exit fee is not charged if three years have passed from the moment of investment.

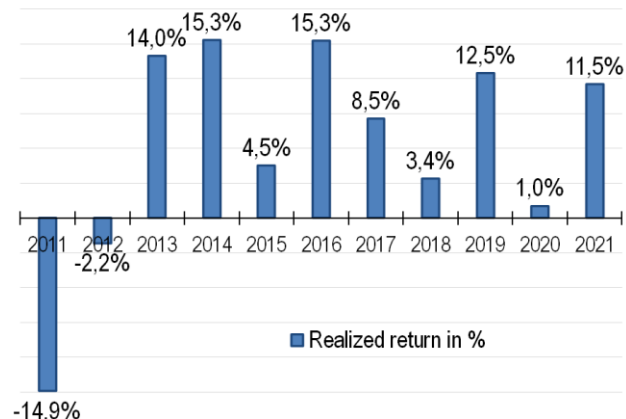
